Program Overview	
Overview of Employee Referral Program (ERP)	The Employee Referral Program (ERP) is a way for UMass Chan Medical School employees to help highly qualified external candidates find a rewarding career at UMass Chan, ForHealth Consulting or MassBiologics. By referring a highly qualified candidate, you will be assisting UMass Chan and Recruitment hire extraordinary talent. You will also receive a \$200 reward (employee subject to required deductions and tax withholdings) if your referred candidate is hired according to the program's rules and policies.
Eligibility – UMASS CHAN Employees	<ul style="list-style-type: none"> All full and part time UMass Chan benefited employees are eligible to participate (excluding the Hiring Manager for the position, all members of the interview team and HR personnel). Only benefited, staff positions posted on the UMass Chan career site will be eligible to receive referrals. The referring employee must be employed by UMass Chan for payment <u>after the new hire has completed 60 days of employment with no break in service</u> to receive the award.
Eligibility – Referral Candidates	<ul style="list-style-type: none"> The referred candidate must be a <u>qualified</u> (as determined by the UMass Chan Talent Specialists), external candidate who has not already applied to the position he/she is being referred to. Candidates are not guaranteed an interview and/or job. Only candidates who meet the qualifications for the position will be considered and evaluated consistent with UMass Chan policies and procedures. <p><i>The following <u>are not eligible</u> for referrals: a former employee, a UMass Chan contractor, a current UMass Chan employee or individuals previously known to the University.</i></p>
Referral Process	<ol style="list-style-type: none"> Employee will email EmployeeReferral@umassmed.edu a completed Employee Referral Program Submission Form that includes referral's name, resume, position title and the requisition number for the position. Employee will instruct the referral to formally apply through the UMass Chan application tracking system via https://www.umassmed.edu/jobs/. <i>(Note: The Talent Specialist will not reach out to the candidate unless they have formally applied).</i>

Employee Referral Program Frequently Asked Questions (FAQ)

1. I work part-time at UMass Chan. Am I eligible to participate in the Employee Referral Program?

Yes, all full and part time UMass Chan benefited employees are eligible to participate (excluding the Hiring Manager for the position, all members of the interview team and HR personnel).

2. I would like to refer a friend of mine who worked at UMass Chan a few years ago. Is my friend an eligible referral?

No, the following are not eligible referrals: a former employee, a UMass Chan contractor, a current UMass Chan employee or individuals previously known to the University.

3. What is the amount of the reward?

The amount of the reward for an employee whose referred candidate is hired and has followed the Employee Referral Program policies and procedures is \$200 (employee subject to required deductions and tax withholdings).

4. When is the reward paid out?

The reward is paid out after the referred employee has been employed by UMass Chan for 60 days without a break in service.
