

INTRODUCTION



fruition since the end of the year.

I am extremely pleased to present this annual report to DMH on the activities of its UMass Center for Excellence in Fiscal Year 2004-2005. The Center for Mental Health Services Research (CMHSR) has continued to flourish and expand its scope of work with DMH, its vendors, and other public sector agencies both within Massachusetts and beyond. The reputation of the Center and its faculty has also continued to grow locally, nationally and internationally. Our work with DMH leadership has become increasingly fruitful and beneficial to our research and service goals. And, of course, our basic research has continued to expand with a series of major new grants applied for during 2005, several of which have come to

CMHSR is unlike most academic research centers. Although we are known and respected as an academic organization around the world, we have, from the beginning, been committed to developing knowledge about mental health services in the Commonwealth with a view to providing state of the art information to Massachusetts residents first. To this end, we are pleased to assist DMH in applying this knowledge in improving the lives of DMH clientele and other people with serious mental illnesses. We are not, and never have been a group of "ivory tower" researchers and are proud to focus on real world problems that make a difference to both service providers and their clientele. As such, we actively engage in training and presentations across the Commonwealth, disseminating the results of our research and that of others in the field in furtherance of the goal of improving access to and the quality of services.

I have been increasingly pleased in the development of the working relationship between CMHSR and DMH leadership over the past year. With Kathleen Biebel directing the efforts of CMHSR, and Fred Altafer coordinating from DMH's end, we have undertaken a number of major projects collaborating directly with DMH. These include:

- an intensive effort to develop a new measure of satisfaction with DMH services
- an on-going evaluation of a DMH initiative to reduce seclusion and restraint in DMH facilities
- the start of a series of brown bag presentations for Central Office staff that we hope will be expanded in the coming year
- the continuation of the annual survey of satisfaction with services at Worcester State Hospital

I believe that one of the greatest benefits to all in the evolving relationship with DMH has been the positioning of Kristen Roy-Bujnowski with DMH for 1 1/2 days of the week. Working with Medical Director Mary Ellen Foti MD on a variety of projects that require immediate research support for DMH has allowed Ms. Roy-Bujnowski to grow as a researcher, and has provided us with better insight into ways we can be of service to DMH. Our Child and Family Services Core also worked closely with DMH to organize a statewide meeting with DMH and DSS stakeholders. And

we have continued to do a substantial amount of training for DMH and DMH vendors across the Commonwealth.

The primary purpose of CMHSR is, of course, to conduct research that will inform the development of services for people with severe mental illnesses. Although last year was, in many ways, a year in which we focused on developing new research proposals for federal and foundation funding, our current research portfolio has continued to grow. We applied for a substantially larger number of grants in '05 than ever before and succeeded in getting funding for 14 of the 21 submitted. At least as important, several of the largest grants submitted during '05 either already have received, or seem likely to receive, funding during the '06 year. This will allow a substantial expansion of our capacity to push forward our understanding of the needs of people with severe mental illness and the best ways to support them.

The last year saw a great expansion of our training in the criminal justice arena, an area of growing importance. A CMHSR team, lead by Bill Fisher, has shown that a large number of people with serious mental illness have criminal records, and other research has already shown that many such people are in our jails and prisons. This information helps underscore and inform the trainings that Al Grudzinskas, Judge Maurice Richardson and their team are doing with police and criminal justice personnel across the Commonwealth.

Tom Grisso, Gina Vincent and Valerie Williams have been tracking the adoption, and analyzing the impact, of the Massachusetts Youth Screening Instrument (MAYSI) by DYS and similar agencies around the country. This instrument, developed by Dr. Grisso, produces a sort of reform from within these agencies by encouraging them to recognize the prevalence of serious emotional problems in their populations.

CMHSR has always had a major interest in consumer operated services and clubhouses. Over the past twelve months, Matt Johnsen has continued analysis of data on consumer operated services and, in collaboration with Colleen McKay, begun a complex analysis of the evidence base on the impact of clubhouse services on many different dimensions of the lives of members. As Dr. Johnsen's attention has begun to focus more on CMHSR's work on seclusion and restraint and consumer satisfaction, Bill Fisher and Chuck Lidz have begun to work more closely with the Program for Clubhouse Research to further develop its empirical base.

The '05 year has also seen important new work from our Child and Family Core. A group led by Kathleen Biebel analyzed Medicaid funding options for children with serious emotional disorders. Jennifer Taub continued her important study of the impact of wraparound based services for children. Joanne Nicholson and Kathleen Biebel received news that they will be funded for a large study of family care management for parents with mental illness and their children; this study has now begun. Dr. Nicholson also received a major honor when the WT Grant Foundation chose her as one of its first mid-career Fellows. This is further recognition of the national importance of her work with parents who have a mental illness. Maryann Davis continued her work with transitional youth and the problems of the mental health system in responding to their service needs including work on the criminal justice involvement.

Paul Appelbaum and I continued our work on issues related to clinical trials and problems in the evidence base that they generate. We received a grant from NIH to do a national survey on the

issue and a fundable score on a large study of the ways in which Institutional Review Boards make decisions about medical studies. In both cases, a major question is the differences in the way in which research involving subjects with mental illness is carried out and regulated.

We are proud of our accomplishments over the past year and expect that CMHSR will continue to grow and that our work with DMH will develop in ways that are of great mutual benefit.

CMHSR EXECUTIVE SUMMARY

Fiscal Year 2005 proved to be another productive year in moving the DMH UMMS Center for Excellence – the Center for Mental Health Services Research (CMHSR) - toward its goal of becoming an internationally recognized academic research center in its field. At the same time, we have strengthened our working relationship to DMH and contributed to improving the services available for people with mental illness. The summary below presents an overview of CMHSR accomplishments as follows:

Section One: Attainment of DMH Contract

A. Grants

The ongoing financial support provided by DMH confers CMHSR with the ability to leverage monies from a variety of other sources in support of research and training. As the Center has grown in expertise and renown, the proportion of monies leveraged as compared to the yearly DMH investment is increasing at an impressive rate. This has the benefit of increasing the cutting edge expertise to local and statewide resources serving persons with serious mental illness.

This section details the grant activity of CMHSR in Fiscal Year 2005, taking into account that some projects may have received notice of funding during FY '05 but will not receive actual funds until FY '06.

CMHSR faculty members receive a variety of grants, large and small, that support the research and policy work of the Center. Sometimes the smaller ones make every bit as great a contribution to mental health services in the Commonwealth as the larger ones. For example, Kathleen Biebel and Joanne Nicholson received an initial grant to describe ways in which Medicaid funding could support innovative services for children. This is of critical importance as funding structures sometimes restrict creative programming for children with serious emotional disturbances. The findings were significant enough that SAMHSA/CMHS awarded a second grant to produce a white paper on the subject.

Similarly, Colleen McKay received a small contract from the Massachusetts Clubhouse Coalition to study the types of employment available for clubhouse members across the Commonwealth. These data provide an important picture of where in the Commonwealth such jobs are available and where they are not, and clarify the type and quality of those jobs.

In some cases major innovations that cannot be funded easily with larger grants can be supported with a series of smaller ones. Al Grudzinskas and a team of CMHSR faculty and staff supported the Massachusetts Mental Health Diversion and Integration Program last year with a series of seven small grants. Although they have reason to believe that the current year may see the beginning of larger and more sustained funding from a single source, they have managed to make a major contribution to people with mental illness in the Commonwealth without such a grant. By coordinating smaller amounts of funding toward the larger goal of training and coordinating first responders and other criminal justice personnel, they continue to facilitate care rather than the arrest of people in mental health crisis.

B. Summary of Grant Funding

Figures reported are the total funds awarded for a grant over the life of that grant, and are not broken down into amounts received during the fiscal year. Figures are inclusive of both direct funds (monies which go directly to the project) and indirect funds (monies which go to UMMS to provide for overhead on the project, the operation of CMHSR, support of the UMMS Psychiatry Department, and support of UMMS).

Section Two: Collaborative Work with DMH

CMHSR and DMH continued to work collaboratively in a variety of ways, including on federally funded projects, on individual contracts with the Department, through the provision of expertise and hands-on assistance with data analysis, literature reviews, and other research support, and working with individual members of the Department to continually discuss and assess upcoming research and the information needs of those working at DMH.

A sample of collaborative projects includes:

- Charles W. Lidz, Ph.D. and Kathleen Biebel, PhD. met regularly with DMH Deputy Commissioner Robert Keane, Ph.D. and Fred Altaffer, Ph.D. to discuss ongoing collaborative efforts, and to assess future research needs of the Department
- Colleen McKay, M.A., C.A.G.S continued to work with clubhouse staff and members in the development of revised performance indicators for DMH contracted clubhouses
- Joanne Nicholson, Ph.D. and Kathleen Biebel, Ph.D. worked with DMH and DSS stakeholders to organize a statewide conference to address the issues of families living with parental mental illness
- Kristen Roy Bujnowski, M.A. provided research assistance to Mary Ellen Foti, M.D. on diverse projects, including improving the readability of consent forms for DMH clients, assisting in the monthly analysis of state hospitals' pharmacy reports regarding the usage of medications and their costs, assisting in the development of a common client list between DMH, DPH, and Mass. Elder Affairs in order to coordinate care plans, and continuing to work on morbidity and mortality reports, on the review of DMH patients who committed suicide, and on the deceased patient profile for the Department
- Thomas Grisso, Ph.D., continued to provide in-service trainings to DMH forensic clinicians on using structured assessment tools in forensic practice
- Jeffrey Geller, M.D. Ph.D., Susan Phillips, B.A., and Jonathan Clayfield, M.A., L.M.H.C. conducted the annual Worcester State Hospital Patient Satisfaction Survey with increased efficiency
- As a way to provide state-of-the art information on key topics of interest to DMH, Gina Vincent, Ph.D. headed the first in a series of presentations to be made at the DMH Central Office when she spoke about use of the Psychopathy Checklist
- Matthew Johnsen, Ph.D., headed two teams of CMHSR faculty and staff to:
 - Provide evaluation support to the SAMHSA/ CMHS grant awarded to DMH to reduce restraint and seclusion practices in inpatient hospital settings
 - Provide consultation through a DMH contract to analyze and evaluate a consumer satisfaction survey to be applied to DMH clients

Section Three: People Served Through the Work of CMHSR

As a way to provide more timely, accurate, and detailed information to DMH, CMHSR developed and initiated a database capable of capturing the activities of the faculty and staff throughout the fiscal year. This database has not only proved valuable in writing this report, but in providing up-to-date information as requested for various other state and university initiated reports. As a result, data has begun to be collected on those who have been directly impacted by the work of CMHSR.


Attendees at CMHSR presentations included a broad spectrum of those who work with people living with serious mental illness: consumers, family members of consumers, advocates, club-house members and staff, service providers, clinicians, administrators, health policy makers, psychologists, psychiatrists, behavioral and social scientists, state commissioners, judges, lawyers, probation officers, police officers, forensic mental health professionals, physicians and nurses, academic faculty, and students of all levels from undergraduate to post-doctoral.

CMHSR faculty and staff gave trainings designed for the following audiences: juvenile court clinic directors and clinicians, probation officers, forensic psychologists and psychiatrists, police academy recruits, police officers, and transit police officers, emergency medical technicians, social workers, service providers; psychologists and psychiatrists, nurses, clubhouse members and staff, DMH administrators, consumers, and psychology doctoral interns.

Section Four: Awards and Acknowledgements of CMHSR's Expertise in the Field of Mental Health Services Research

CMHSR is host to outstanding faculty with both local and national standing. This was recognized in FY '05 through the presentation of the following awards:



Thomas Grisso, Ph.D. was awarded the prestigious Isaac Ray Award by the American Psychiatric Association. The Isaac Ray Award is the APAs highest recognition in Forensic Mental Health; it honors those whose work contributes significantly to the field of forensic psychiatry.



Matthew Johnsen, Ph.D. was presented the 2005 Unibank Redefining Community Award by Alternatives Clubhouse in Whitinsville, MA. Dr. Johnsen was honored for his contributions toward building a better community.



Joanne Nicholson, Ph.D. was honored with the WT Grant Foundation Distinguished Scholar Fellowship. The WT Grant Foundation Distinguished Fellows Program supports the work of influential policy-makers, practitioners and researchers in an effort “to increase the supply of demand for and use of high-quality research in policy and practice efforts to improve youth outcomes.”

Joanne Nicholson Ph.D. and Linda Weinreb, M.D.’s Worcester Homeless Families Program was bestowed with the SAMHSA Exemplary Program Award for its excellent work.

Judge Maurice Richardson (ret.) was distinguished with the 2004 Judicial Advocacy Award by NAMI/ Massachusetts. The NAMI-Massachusetts Judicial Advocacy Award was given to the Hon. Maurice H. Richardson in recognition of his tireless efforts in seeking to develop effective programs to divert persons with mental illness out of the criminal justice system and into appropriate treatment.



Section Five: Information Disseminated by CMHSR

Over the past two years, CMHSR has placed increasing emphasis on disseminating information gained through research conducted at the Center to a broader audience, including to researchers in other fields, mental health workers, consumers, advocates, family members, policy makers, administrators, legislators, and to the general public. The benefit of this effort is not only a more educated audience, but one that can advocate for state-of-the-art services. Dissemination efforts included the following:

- **CMHSR Website:** Maintained by Susan Phillips, the CMHSR website contains detailed information on associated faculty, core areas of research interest, major projects being undertaken, and references to selected publications. Topic Areas Addressed By CMHSR Over The Past Fiscal Year

1. Collaborations with the Department of Mental Health

- **Children and Family:** Maryann Davis presented to DMH Forensic clinicians on working with youth in transition to adulthood; and Joanne Nicholson and Kate Biebel completed their work with DMH and DSS in organizing a statewide conference convened in April 2005 for stakeholders addressing issues of families living with parental mental illness.
- **Clubhouses, Employment and Rehabilitation:** Colleen McKay worked with DMH Coordinator Bobby Spofford developing and revising performance indicators, measures and definitions of the DMH Performance Based Contracting system for Clubhouses.
- **Law and Mental Health:** Tom Grisso conducted the annual in-service training for DMH forensic clinicians, and Kristen Roy-Bujnowski assisted Mary Ellen Foti in analyzing the readability of informed consent forms used with DMH clients.
- **Mental Health Services and Systems:** Matt Johnsen began work on the project evaluation of the DMH SAMHSA/ CMHS-funded Reducing Restraint and Seclusion in Adult Inpatient Psychiatric Facilities project. He also led the effort to provide consultation on a consumer satisfaction survey to be used with DMH clientele. Jonathan Clayfield and Sue Phillips again collected survey data and conducted analyses of these data regarding patient-satisfaction at Worcester State Hospital. Kristen Roy-Bujnowski assisted Mary Ellen Foti with analyses of state hospitals' pharmacy reports regarding the use of medications and their costs. Albert Grudzinskas, Judge Maurice Richardson, Jonathan Clayfield and Kristen Roy-Bujnowski, along with DMH's Bob Keane, presented at the National Association of State Mental Health Program Directors (NASMHPD) Conference in Baltimore, MD. Gina Vincent presented on the use of the Psychopathy Checklist (revised) and its screening version for the DMH Mentally Ill and Problematic Sexual Behavior Program.
- **Other:** Bill Fisher began working with key stakeholders and state agencies to consider how best to resolve the issue of the chronically homeless population in and around Boston, MA. Kristen Roy-Bujnowski worked on a number of additional projects, including: co-chairing a sub-committee of the Massachusetts Coalition for Suicide Prevention; analyzing data from the Health Behaviors Risk Factor Survey, and assisting with the Community First initiative in which DPH, MA Elders Affairs and DMH are looking to find common clients, develop profiles, and create care plans.

2. Children and Family

a. Children with Serious Emotional Disturbance (SED)

- **Child-based wraparound services:** Jennifer Taub continued her study of the impact of the relationship between a child-client's caregivers and wraparound team members in providing wraparound services, and made several presentations on the subject including: the role of child

and family strengths in wraparound services, the use of respite and flexible funding in wrap-around services, the psychological and functional adjustment over time in a wraparound service, and with Christina Breault in the lead, presented on caregivers' opinions of wraparound services.

- **Issues around children with SED and Medicaid reimbursement:** Kate Biebel, with Joanne Nicholson and Valerie Williams, identified innovative and exemplary uses of Medicaid and SCHIP as a funding source for systems of care for children with SED.
- **Quality of care for children and their parents:** Jennifer Taub developed a study to examine the relationship between alliance and treatment engagement for children in intensive case management and individualized support services, focusing on parent advocates and clinician case-managers, and considering the role of stress in the relationship.

b. Families and Parenting

- **Services for families with parental mental illness:** Joanne Nicholson and Kate Biebel, along with a broad array of colleagues, continued their work on addressing the service system needs of families with parental mental illness. Now funded, they developed a proposal to work with Employment Options Inc., a psychosocial clubhouse in Marlborough, MA to test an innovative model of family care management for families living with parental mental illness. The project will allow them to assess the issues around implementing such a program in the community and at the agency level. Joanne Nicholson also received a W.T. Grant Fellowship to study welfare system strategies that can benefit the children of parents with serious mental illness. Joanne and Kate present regularly on these issues, and FY '05 was no exception. In various combinations they presented and wrote on topics including: determining the issues facing families with parental mental illness, looking for opportunities to collaborate between child and adult services, the need for service system transformation to care for families living with parental mental illness, identifying key interventions with such families, and building an evidence based practice basis for the treatment of this population. In addition, Betsy Hinden and Joanne Nicholson presented on the needs of parents in systems of care programs.

- **Child abuse and resiliency:** Joining the Center in FY '05, statistician Ken Fletcher brought to the fore his work on child resiliency following maltreatment, including presenting on his work with the Child Abuse Prevention and Protection Collaborative (CAPP). Jennifer Taub also wrote on strengthening resiliency for children through school wide violence prevention programs.

- **Issues around psychopharmacological prescribing practices for children:** Jennifer Taub and Matt Johnsen published articles describing issues facing pediatricians, case managers, and parents when psychoactive medications are prescribed for children.

c. Transition Age Youth

- **Services for transition age youth with mental disorders:** Maryann Davis continued her work identifying current services and supports for transition age youth nationally. To this end, her work has included studying the availability of appropriate transition programs; studying the establishment and maintenance of transition services that span the child and adult system; reviewing federal policy and programs that impact transition age youth with mental health

conditions; and studying policies that promote or interfere with continuity of care throughout the transition age. In particular this year, she presented and published on a number of transition issues including: the collision of institutions and individuals as they seek to help youth with mental illness as they transition through systems, the developmental differences between young and less young adults, and the issue of substance abuse among transition age youth.

3. Clubhouses, Employment and Rehabilitation

- **Furthering employment opportunities for people with mental illness:** Colleen McKay worked with the Massachusetts Clubhouse Coalition to expand employment opportunities for clubhouse members in Massachusetts and five other states.
- **Clubhouse research programs:** Colleen McKay has been involved in clubhouse research programs, including looking at innovative approaches to clubhouse member recovery, and gathering further data on employment outcomes in Massachusetts clubhouses. Along with Matt Johnsen, she has published and presented on the issue of employment transitions for clubhouse members.
- **Clubhouse effectiveness and the evidence base:** Matt Johnsen and Colleen McKay have both been researching the elements of clubhouse and consumer-operated services, the effectiveness of the clubhouse model, and measures of fidelity in relation to the clubhouse model. These studies are designed to assess the case for clubhouses as an evidence-based practice.
- **Cost and cost-benefit of clubhouse programs:** Along with Brian Yates, Matt Johnsen and Colleen McKay wrote an article describing the characteristics and costs of clubhouses and the relationship between costs and cost-procedure in international clubhouses.
- **Clubhouse wellness programs:** Matt Johnsen and Colleen McKay followed up on last year's work around developing a study of structured physical exercise programs for clubhouse members with a description of how to integrate such a program in other ICCD certified clubhouse programs.
- **Other:** Bill Fisher wrote on the history of work for those living with mental illness, and summarized current research on employment for this population.

4. Homelessness/ Trauma

- **Homelessness:** Joanne Nicholson and Valerie Williams worked with a number of CMHSR faculty and staff on a study to adapt and test the Collaborative Care Model (CCM) for homeless mothers with depression who are receiving services in a primary care setting. They also conducted a comparison of homeless mothers in Worcester, MA. Valerie Williams furthermore described methods of measuring homelessness and residential stability.
- **Trauma in shelter settings:** Joanne Nicholson, Kate Biebel, and Valerie Williams continued their work on homeless parents and their families, presenting on the issue of creating opportunities for success in working with trauma survivors in shelter settings. In addition, Joanne Nicholson and Valerie Williams studied the consequences of trauma for mothers, motherhood and mother-child separations in women with co-occurring disorders and histories of

violence, and the issues and benefits of integrating behavioral health, trauma, and parent support services with primary care for homeless mothers and their children.

5. Law, Ethics and Mental Health

a. Adult Criminal Justice and Mental Health

- **Training and education on forensic issues:** Judge Maurice Richardson (ret.), Al Grudzinskas, Ira Packer, and Tom Grisso began a Forensic Training Program to teach psychiatrists, psychologists, and social workers about expert testimony and mental health and the law, Paul Appelbaum wrote about mental health training for law professionals, and Bill Fisher published on how to criminalologically inform mental health policy and services research.
- **Behavioral genetics and crime:** Paul Appelbaum published on the role of genetics in the prevention and punishment of crime.
- **The interface between mental health and criminal justice systems:** Bill Fisher continued in his role with the Center for Mental Health Services and Criminal Justice Research as it seeks to bring together mental health services research, criminology, and the law to look at issues at the interface of the criminal justice and mental health systems. Al Grudzinskas wrote a chapter in the Attorney's Handbook about mental illness and treatment considerations.
- **Forensic evaluations:** Tom Grisso addressed competence to stand trial in a training program for DMH forensic clinicians. Gina Vincent continued her research into psychopathy, its assessment, risk and treatment. Albert Grudzinskas and Bill Fisher presented on understanding the evidentiary requirements for the introduction of psychological tests in expert testimony.

b. Ethics and Mental Illness

- **Competence to consent:** Tom Grisso studied advances in understanding the competence to consent to treatment, and Paul Appelbaum published and presented on assessing the capacity of older patients with schizophrenia, Alzheimer's disease, or diabetes mellitus to consent to treatment.
- **Coercion and leverage in treatment:** Jeffrey Geller presented on the criteria for involuntary, coercive, and pseudo-voluntary treatment of persons with serious mental illness, and Paul Appelbaum discussed the use of leverage, including leverage over a patient's money, to promote adherence to psychiatric treatment. Joanne Nicholson examined the use of child custody as a method of obtaining treatment compliance in parents with mental illness.
- **General ethical issues in psychiatric practice:** Paul Appelbaum continued to bring to the fore broad ethical issues and dilemmas facing practitioners and researchers today through a variety of presentations and publications, including ones on neuroethics, psychiatric genetics, and the ethical issues facing those in the practice of forensic mental health.

c. First Responders to Mental Health Crisis

- Albert Grudzinskas and Judge Maurice Richardson (ret.) along with their team, expanded the training of first responders to mental health crisis through their Massachusetts Mental Health

Diversion and Integration Program. Trainings were conducted at three Massachusetts State Hospitals, the Probation Officer Training Academy in Clinton, the Boston Police Academy, Worcester Police Academy, and the Massachusetts Bay Transportation Authority. The team also continued their work on service integration in support of persons with mental illness who might otherwise be arrested with a number of articles and presentations documenting the success of their on-going efforts.

d. Juvenile Justice and Mental Illness

• **Mental health instruments for juvenile offenders:**

i. **Massachusetts Youth Screening Instrument (MAYSI-2):** Tom Grisso and Gina Vincent continued the development of national norms for the MAYSI-2. The instrument will assist juvenile justice systems throughout the U.S. to better identify youths with immediate mental health needs. Along with Bill Fisher and Valerie Williams, Tom Grisso also spearheaded an effort to provide technical assistance to juvenile justice programs around the country in implementing the MAYSI-2 in juvenile detention and correction programs. In various presentations, this same group also discussed the history of the MAYSI-2 project, the needs of juvenile justice youth in relation to the instrument, issues related to gender and domestic violence and the MAYSI-2, and what adoption of the instrument around the country says about various systems. Tom Grisso and Gina Vincent began a study determining whether there are gender or race related biases in the measure of psychological disturbances among juveniles.

ii. **Psychopathy Checklist: Youth Version:** Gina Vincent presented on the validity of the Psychopathy Content Scale in the Psychopathy Checklist: Youth Version. She also examined the trajectories of youths assessed through the instrument, its effectiveness with girl offenders, and the impact of adult concepts to youthful offenders and its implications for future risk assessment and the juvenile justice system.

• **Juvenile risk assessment:** Gina Vincent developed a study that would identify seriously conduct-disordered children at highest risk for chronic violence and criminal offending, and that would improve current intervention practices and juvenile forensic assessments aimed at preventing further risk.

• **Juvenile offenders' competence to stand trial:** Tom Grisso and Gina Vincent began developing and disseminating a method of evaluating youths' competency to stand trial. Tom and Gina also conducted a training on the issue as a guide to clinical practice. Tom Grisso addressed the issue at a variety of presentations, and published a manual for use in clinical practice on the subject.

• **Clinical assessment of juveniles:** Across a variety of venues, Tom Grisso discussed clinical assessments of juveniles in delinquency cases, and of the risk of violence in these cases. He also conducted a training for state juvenile experts in Pennsylvania on implementing health screening and assessment in juvenile justice settings, and wrote a book chapter specific to the issue.

• **Mental illness and the juvenile justice system:** Tom Grisso published and presented on the existence of and reaction to mental illness in youth entering the juvenile justice system, and discussed the need for reform in many systems.

e. Research and Clinical Trials

- **Institutional Review Boards (IRBs):** Chuck Lidz and a team of leaders in the field of research ethics submitted a study for review by NIH that examines how IRBs in top academic medical settings decide on the risks of medical research. The project received a promising score; funding is anticipated in the near future.
- **Research ethics and clinical trials:** Chuck Lidz, Paul Appelbaum, and Steve Banks started work on a project that considers the conflicting issues facing medical and mental health researchers working on clinical trials given the need to conduct rigorous research and the need to provide best care to patients in research studies. Chuck Lidz and Paul Appelbaum also considered the issue from the patient's perspective when they published a number of articles and made presentations on the "therapeutic misconception," a failure to appreciate the differences between receiving ordinary clinical care and participating in a clinical trial. Chuck Lidz furthermore published an article summarizing authors' reports of integrity problems in clinical trials.
- Confidentiality and consent in clinical practice and research: Paul Appelbaum published his work on issues with confidentiality in the field of mental health, and wrote about the capacity of patients with schizophrenia to consent to participation in research.

f. Violence and Mental Health

- **Risk assessment of sexual violence:** Gina Vincent, Al Grudzinskas, Steven Banks, and Valerie Williams developed a study to test the reliability, validity, and generalizability of a new assessment tool – the Risk for Sexual Violence Protocol (RSVP) – that assesses chances of recidivism following treatment for sexual violence.
- **Risk assessment of adult violence:** Ira Packer and Gina Vincent presented on the Psychopathy Check List Screening Version (PCL: SV) and how it has been used to inform management decisions, and Paul Appelbaum discussed the risk factors for violence in the mentally ill in a further presentation.

g. Other

- **Pedophilia:** Ken Fletcher and colleagues developed a study that would improve understanding of pharmacologically treating patients diagnosed with pedophilia.

6. Mental Health Services and Systems

- **Transition to adulthood and service systems:** In a variety of presentations and articles, Maryann Davis commented on the need to reduce barriers to system supports for youth in transition from childhood to adulthood, the current efforts being made by various states nationwide, and the gaps in said systems.
- **Service system reform:** Paul Appelbaum published on the obstacles to the reform of mental health systems, including funding and fragmentation.

7. Other

- **Medical issues for the non-mentally ill population:** As statisticians, Steve Banks and Ken Fletcher lent their expertise to numerous medical studies, including those examining family burden and breast cancer, the development of tests to measure cough severity and its impact on the quality of life, and the impact of various treatments on septic shock.
- **Mental health and medical issues:** CMHSR faculty and staff's work focused on a broad variety of topics in FY '05. These included: managed care and psychiatry; suicide; dangerous severe personality disorders; medical advance care planning for persons with serious mental illness; and end of life treatment preferences for those living with mental illness.
